LAND OWNERS IN THE TOWN OF GREENWOOD**

CHART OF SERVICE FEES

(All Service Fees are Non-Refundable)

Initial Service Fee - \$75.00 Primary Residence of Property Owner

Initial Service Fee – \$100.00 Rental Property or Tenant other than Property Owner

Transfer Fee – A transfer fee of **\$35.00** will be imposed when a customer with an existing account, in good standing, desires to transfer to new dwelling and retains same customer name. The transfer fee can also be used to transfer an account from a deceased family member's name whose relationship involves grandparent, parent or child exclusively. **No fee will be assessed if married, living at same residence and one spouse dies.** The account will be changed to reflect the name of the surviving spouse. Accounts where the customer is deceased must be closed within ninety (90) days or transferred as stated above. An Application for Services will be required on all transfer of accounts.

New Tap Fee - \$750.00

(IN THE EVENT THE COSTS OF MATERIALS AND LABOR EXCEED THIS AMOUNT THE
INSTALLATION COSTS WILL BE FIGURED ON A COST PLUS BASIS.)

Returned Checks – When the bank returns a check, the account is scheduled for disconnect. Notification is not sent out to customers regarding a returned check. Return check fees are the amount of check plus a return check charge: Under \$50.00 -\$25.00 fee; \$50-\$200 - \$30.00 fee; over \$200 - \$40.00 fee. **PERSONAL CHECKS WILL NOT BE ACCEPTED IF 2 CHECKS ARE RETURNED ~ CASH OR MONEY ORDERS WILL BE REQUIRED.**

Tamper Fee – \$75.00 (IF CUSTOMER TURNS ON WATER AFTER TOWN TURNS OFF)

Reconnect Fee – \$40.00 (FOR NON-PAYMENT OF WATER AND GARBAGE BILL)

DEAR WATER AND GARBAGE USERS:

Please read the following information carefully. If you have any questions or concerns, please ask for clarification.

RULES FOR USE OF GARBAGE FACILITY:

MONTHLY GARBAGE FEE: \$22.00 (Included in monthly billing)

Garbage can be taken to the trash facility on Saturdays only. The trash facility is located at the west end of Knapp Street. Additional rules and regulations are attached to explain dumping, recycling and the roll off container.

Each account is issued a garbage card for access to utilize the Garbage Facility. If you lose the card and need to replace it, you will be charged \$2.00. **NO CARD, NO GARBAGE DUMPING.** Your failure to pay the monthly fee will be subject to a lawsuit, court cost and attorney fees. If you move, please return the card to the Town Hall.

The rolloff container is available **ONLY** on the **1st and 3rd Saturday** of each month and costs **\$30.00 per use**. The \$30.00 charge will be added to your monthly billing upon use of the rolloff container.

RULES FOR USE OF WATER:

MONTHLY WATER BILLING: \$16.00 for the first 500 gallons
\$ 6.00 per each additional 1,000 gallons

Water and garbage bills will be sent at the end of the month and are due by the 10th day of the following month. A 10% late fee penalty will be applied on the 16th of the month for all unpaid balances not received by the end of business of the 15th. If the total bill, including late charges is not paid by the end of business on the 20th of the month, your services will be turned-off/suspended at 9:00am on the 21st of the month. If your water/garbage is turned-off/suspended for non-payment, the entire bill including late fees and \$40.00 reconnect fee must be paid in order to reactivate your account.

PAYING YOUR BILL:

You can pay your bill by cash, check, money order or debit/credit card at the Town Hall during business hours. You may also leave payments in the secure drop box located on the drive-through side of the building outside of business hours.

PENALTY: A 10% late fee penalty is added to the account for all unpaid balances not paid by the 15th of each month.

RE-CONNECT FEE: To avoid a disruption in service all account balances must be paid by the 20th of each month. Delinquent accounts will be disconnected at 9:00am on the 21st. A **\$40.00** Reconnect Fee will be charged to the account.

TAMPER FEE: **\$75.00** fee will be charged if a water meter is turned back on after a town employee has cut water off, or the meter is tampered with.

RETURNED CHECK FEE: When the bank returns a check, Town Hall will attempt to contact the Payee regarding the returned check and fee. The Payee will be given no more than 24 hours to make restitution for the returned check and fee. If payment is not received the water service at the residence will be turned off until restitution is made to the Town. Return check fees are \$25, if the face value does not exceed \$50, \$30, if the face value exceeds \$50 but does not exceed \$300, \$40, if the face value exceeds \$300.

The above will be strictly enforced. Your cooperation is appreciated.

If a meter is broken or stopped, the water usage will be averaged for the last 12 months or however many months the user has had an account. Customers are given a one-time courtesy adjustment for major water leaks. If you have any questions regarding your water/garbage billing, please contact Town Hall.

PERMITS: Before building any structure or adding to your home or property, please contact the Town Hall for the proper permits.

GARBAGE FACILITY

Policy and Procedures – Effective October 1, 2025

ADMISSION

The Greenwood garbage facility is for the exclusive use for the residents and businesses, located within the corporate limits, of the Town of Greenwood upon presentation of your garbage card to the Attendant.

Use of the garbage facility by non-residents is not allowed. Garbage and debris generated outside of the corporate limits of Greenwood is prohibited. **Removal and/or salvaging of items brought to the garbage facility for disposal is prohibited.** Violation of these established policies and procedures are subject to investigation and prosecution.

If you have any questions about an item, please contact Town Hall before taking the item to the garbage facility.

HOURS

**Saturdays Only
7:30am to 4:30pm**

HOUSEHOLD GARBAGE

Household garbage must be in tied garbage bags to be accepted at this facility. Loose garbage or busted bags are not allowed. Garbage must be placed in the designated dumpsters for household garbage. The Attendant on duty will provide assistance if needed.

ROLL-OFF CONTAINER

The roll-off is **only** open on the **1st and 3rd** Saturday of each month and this service **IS NOT INCLUDED** in the monthly garbage rate. **There is a \$30.00 PER LOAD fee** for residents who need to use the 40-yard roll-off container, and **this service is available ONLY for the use of Town of Greenwood households located within the city limits.** The garbage attendant will have an authorization form that will need to be completed and signed prior to use, and the \$30.00 fee will be added to the current month billing cycle. Residents will be required to present their garbage card to the attendant to verify the account number for billing. There will be no exemptions given to the requirements for using the roll-off.

Some items cannot be placed in the roll-off container. Property owners of rental property located within the Town of Greenwood are not allowed to use the roll-off container to clean out rental property. If contractors or companies are working at your home, require them to include trash removal as part of the job. If arrangements cannot be made with the contractor, then hire a contractor to dispose of these items or take them to a landfill for disposal.

YARD TRASH

Yard Trash – grass clippings, leaves, tree limbs and pine straw and shrub trimmings.

Yard trash can be taken to the garbage facility on the **2nd and 4th** Saturday of each month. In order to meet State of Florida requirements, the Town of Greenwood requires the separation of yard trash from residential garbage, as yard trash cannot be placed into lined landfills.

Your help is required in order to ensure compliance. Therefore, we ask that you follow these guidelines.

1. Yard trash should be placed in the area designated for yard trash at the Greenwood garbage facility. Before entering this area, the garbage attendant will inspect the items to ensure compliance.
2. Please ensure that tree limbs are no more than eight inches in diameter and eight feet in length.

Other debris such appliances, furniture, construction/demolition, white goods, etc. are not allowed in the area designated for yard trash.

HAZARDOUS MATERIAL

Because of potential health and safety concerns, some items cannot be disposed at the Garbage facility.

Items which are considered toxic and hazardous include but are not limited to:

- Lead acid batteries, used motor oil, computer, televisions
- Automotive parts, tires, pesticides, paint and solvents, pool chemicals, materials containing asbestos, household cleaning materials, medical waste, etc.

The garbage facility has designated areas for recycling. Please see garbage attendant for assistance.

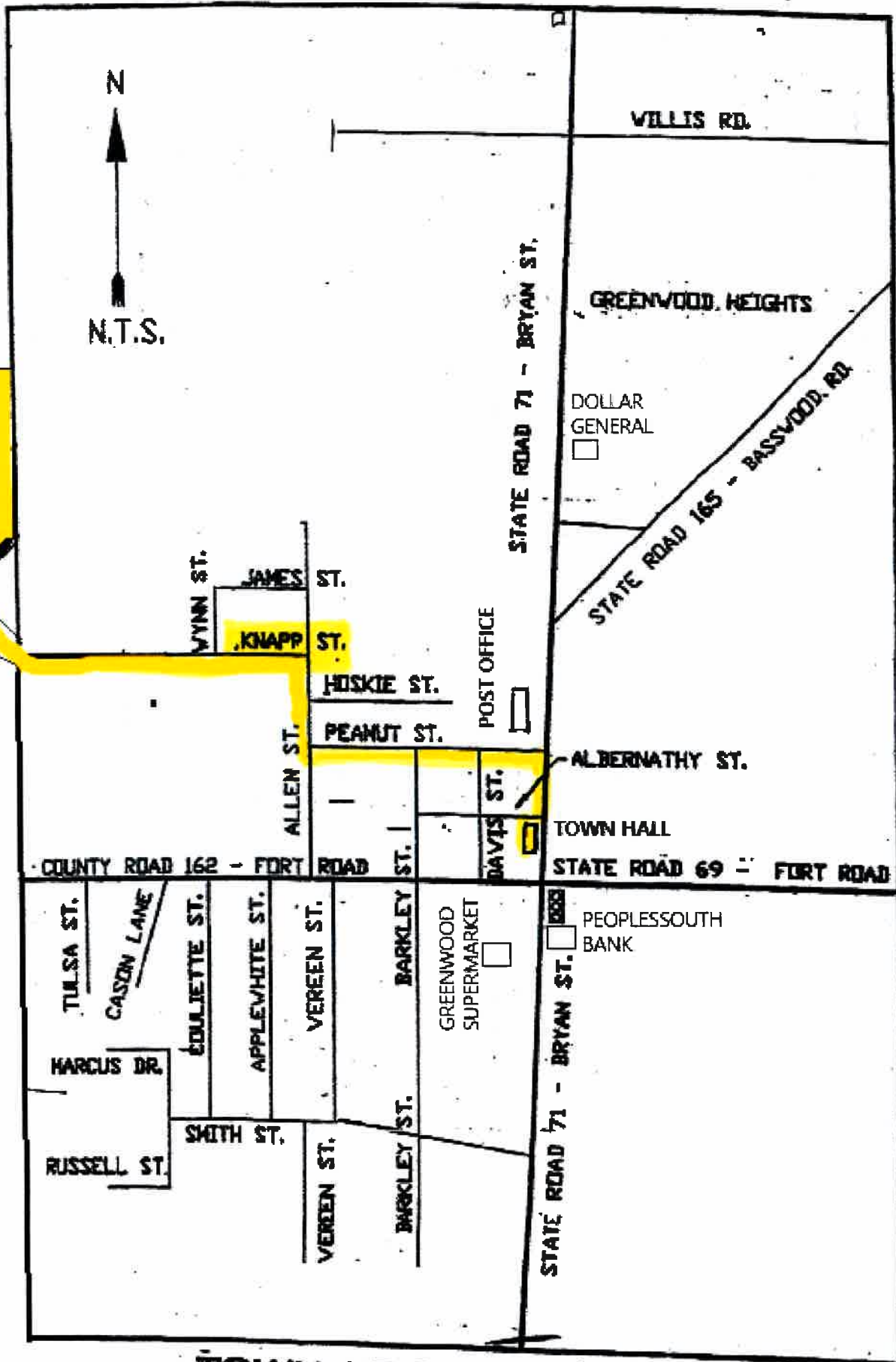
